

# **Executive summary**

#### Introduction

The purpose of the report is to analyze and design an information system for UNICEF Child Care. The report will examine and document the functional and nonfunctional requirements of the online system needed by the organization. A suitable approach will be selected for system development incorporating all the needs of the new system. Work breakdown structure and Gantt chart will be prepared for project scheduling. Apart from that, project cost benefit analysis is conducted to forecasts budget of system development project of UNICEF Child care. The report will also provide information about different stakeholders and investigation techniques employed for system analysis.

### Task 1 Approach to system development

### **Developing information system**

UNICEF Child Care is an organization based in Australia working to offer caring and supervising facilities for children ranging from 6 weeks of age to 13 years of age (Unicef.org.au, 2018). The parents of the children in return pay money for their services and facilities. The operational system of the UNICEF Child care for payment is totally manual based. The parent of the children taken care by the organization has to visit bank in order to do the payment and deposit the amount on their trust account. After depositing the money, they have to call or send email to the staff to get invoice or receipts for that payment. Apart from that, ordering and estimating of supplies along with maintaining accounts manually is a difficult task. Thereby, the organization has decided to shift from manual process to online process.

The problems identified in the current system of UNICEF Child Care are:

- Employees need to present all the time to attend and answer calls and respond to emails from parents.
- Need to send year statement providing detailed information regarding payment
- Due to inaccurate estimation of stock level, there was wastage of food supplies.

After analyzing and evaluating the problems of the system, an appropriate approach required to be selected for system development. Therefore, waterfall model has been chosen for this purpose.

### **Justification for select approach**

According to Azhar et al. (2015), waterfall model helps to describe the development stages in a linear and sequential order. This method is basically employ to divide the project into different phases so that it can be completed in a coherent and organized manner without any overlapping of tasks and activities. The waterfall model is a simple system development approach which is quite easy to understand and apply. Besides, the approach is very convenient for managing the rigidity of tasks and activities involved in the project by dividing it into phases, each phase comprising of particular deliverables associated with reviewing process (Dennis et al. 2015). The following module is well suited for smaller project like UNICEF Child Care, taking into account very requirements of the system development in detailed order.

### Task 2 System requirements

## **Functional requirements**

### Control and management system

The new development project of UNICEF Child Care will consist of control and management system. The following system will help to collect and manage the details of children properly and accurately such as name, address, postal address, phone number, email address, etc. It will help to create a database for all information collected (Hakansson, 2015).

#### **Inventory management system**

The inventory management can be used for keeping track of food supplies and managing inventory stock of the organization. Food supplies for the children can be updated and will ease the process of distribution to different centers. Apart from that, order of food supplies can be placed online (Hermann *et al.* 2016).

#### **Electronic payment system**

As per the opinion of Ioannidis *et al.* (2016), the electronic payment system will provide options for online money transfer and credit or debit card option to the parents. This system will ease the process of transaction and depositing money. The parents will able to generate the receipt for their payment through the system under their client login.

### Financial management system

Financial management system will help to keep the records of all business transactions and payment of the organization. It will manage all the process of accounting and finance which will reduce load of paperwork of the organization (Kerzner and Kerzner, 2017).

### **Non-functional requirements**

### Reliability

The information maintained in the system should be reliable and accurate for processing and evaluation purposes. Besides, the system should be able to detect problems and managed them as well.

### **Flexibility**

The developed system should be to be flexible to support update and adapt with changes made later on.

#### **Security**

The system should support strong security and authentication measures to protect and secure the data as well as user.

# Discussion of project cost benefit analysis

Project cost benefit analysis is an accounting estimation tool used to determine the budget forecast. 


Figure 2: Work Breakdown Structure




Figure 3: Gantt chart
